I do solemnly declare that,

On November 11 2017, I was parked at Val d'Or in front of the Jean Coutu. I was picking up my sister. I parked there for about three minutes and she came out but when I wanted to back up, there was a police at the back of my truck. I couldn't go and he told me "you're not supposed to park there" and after, he went to his truck.

Q1: He gave you a ticket?

R1: Yes.

Q2: Why the police officer taught that you were not supposed to park there?

R2: He told me that it is a parking for the wheel chair and I told him I'm not parking there. Maybe I was little on the line.

Q 3: So you were not in the particular place of parking or maybe a little on the line?

R3: Yes and the police was standing near my window and a lady came out, a French lady, and she just looks at me and said "he gave you a ticket for that?" and the police said "go, I'm not talking to you." The lady was standing there and she said "for that, a ticket!" and the police said again "GO! GO! GO!" and the lady walked and I was laughing after.

Q4: You said you were parked there for almost three to five minutes?

R4: Yes.

Q5: All this time were you in your vehicle?

R5: Yes. All this time I was inside of my truck and my sister was inside the Jean Coutu. I was just waiting for her. She got some things, some water and pills. After that, when she came out, she saw the police.

Q6: Did you kept your vehicle running all the time she was inside?

R6: Yes.

Q7: Have you ever made a complaint regarding that situation?

R7: No.

Q8: If you wanted to do it, do you know where you should go?

R8: Because, I heard Stella talking about someone that made a complaint about the SQ and she told me "bring your ticket I want to see it" and I showed to her.

Q9: Do you know where to make a complaint beside the commission?

R9: No. Someone told me "did you already paid this?", and I said yes and he thinks I must have wait for it. I already paid for my ticket and it's too much for only 5 min of parking.

Q10: Do you think that this situation would have been treated differently if you were a non-native?

R10: Yes, because I heard about some other guys that were doing the same... stopping by the SQ.

Q11: So for your knowledge it wasn't the first time that something like this happened?

R11: Yes, it's what I heard from other guys.

Q12: Do you have suggestions or recommendations to improve the services?

R12: I think OPP is better than SQ, you never get a ticket or complain about anything with OPP. I'm always in Ontario, I came back from Ottawa you never heard about even anything on the road or arguing or something. I think they are different Quebec and Ontario.

Q13: Do you know if there are things that are in place with the OPP that can prevent for those kind of situation that we do not have in Quebec?

R13: Yes, it's different.

Q14: Like what?

R14: They talk to me when we saw them sometimes on the highway when I stop, like in the Tim Hortons. He knows I'm a native. He asked where I come from. I told him Baie-James and he only said "it's very far".

Q15: They come forward to you?

R15: Yes, but the SQ it's not the same. They will look at someone or watch someone. I heard about some other guys that had the same things with the parking.

Q16: In Val-d'Or?

R16: Yes, in Val-d'Or. Just in the town of Val d'Or, not in the other towns.

Q17: Do you know if it's the same police officer?

R17: I don't know.

Q18: Do you remember the name of this police officer?

R18: No, it's a guy. I don't know.

Q19: What's the name of your sister?

R19: Beatrice Napash.

Q20: Is there anything that you would like to mention?

R20: No, that's it.
